The only personal data that Kunitat Festi Esterni Qormi currently collects through its websites is the information you voluntarily give us when you use our sites.

For example, you may use this site to contact us with questions and comments. When you fill out a form on our websites, you may provide your name and other contact information, including your company's name, your e-mail address, and your mailing address or the mailing address of your company or other personal information.

## Use of Personal Data Collected

Kunitat Festi Esterni Qormi uses the personal data information you provide to answer the query you will have posted through the site. Kunitat Festi Esterni Qormi and our affiliates also use this information to help us improve the content and functionality of our websites, to better understand our customers and markets, and to improve our products and services. - (e) personal data that is processed is adequate and relevant in relation to the purposes of the processing;
- (f) no more personal data is processed than is necessary having regard to the purposes of the processing;
- (g) personal data that is processed is correct and, if necessary, up to date;
- (h) all reasonable measures are taken to complete, correct, block or erase data to the extent that such data is incomplete or incorrect, having regard to the purposes for which they are processed;
- (i) personal data is not kept for a period longer than is necessary, having regard to the

purposes for which they are processed.

Personal data may be processed only if:

- (a) the data subject has unambiguously given his consent; or
- (b) processing is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract; or
- (c) processing is necessary for compliance with a legal obligation to which Kunitat Festi Esterni Qormi is subject; or
- (d) processing is necessary in order to protect the vital interests of the data subject; or
- (e) processing is necessary for the performance of an activity that is carried out in the public interest or in the exercise of official authority vested in Kunitat Festi Esterni Qormi or in a third party to whom the data is disclosed; or
- (f) processing is necessary for a purpose that concerns a legitimate interest of Kunitat Festi Esterni Qormi or of such a third party to whom personal data is provided, except where such interest is overridden by the interest to protect the fundamental rights and freedoms of the data subject and in particular the right to privacy.

## Anonymous Data Collected

In addition to the information you provide when you use our websites, Kunitat Festi Esterni Qormi uses technology to collect anonymous information about the use of our websites. For example, we use technology to track how many visitors access our websites, the date and time of their visit, the length of their stay, and which pages they view. ## Subject Access Policy

Kumitat Festi Esterni Qormi at the request of the data subject shall provide to the data subject, without excessive delay and without expense, written information as to whether personal data concerning the data subject is processed:

Provided that a request by the data as aforesaid shall only be made by the data subject at reasonable intervals.

Any such application shall be made in writing to Kumitat Festi Esterni Qormi and is to be signed by the data subject.

If such data is processed Kumitat Festi Esterni Qormi shall provide to the data subject written information in an intelligible form about:

- (a) actual information about the data subject which is processed;
- (b) where this information has been collected;
- (c) the purpose of the processing;
- (d) to which recipients or categories of recipients the information is disclosed; and
- (e) knowledge of the logic involved in any automatic processing of data concerning the data subject.

## Governing Law.

This privacy policy is governed by and construed in accordance with the laws of the Republic of Malta and relevant EU legislation.
